This matter came before the Court on Settlement Class Representatives Motion for an Order regarding case administration on November 12, 2021, and the Court having heard argument of counsel and being otherwise duly and sufficiently advised, IT IS HEREBY STATED and ORDERED as follows:


1. The Court is taking under advisement the Motion's request to order that CR 5 service be limited to Settlement Class Counsel and counsel for the named Plaintiffs and the Burley Tobacco Growers Cooperative Association;
2. Any person that is determined not to qualify as a settlement class member or whose W-9 form has not been accepted for receiving payment of settlement distributions has the right to object to that determination and ask the Court to make a ruling of whether that person is to receive any settlement distribution, by:
 - a. Stating the objection in writing and submitting it so that it is received by the Court within thirty (30) days of the date that written notice of the adverse determination is mailed to that person; and
 - b. Mailing the written objection to: (i) Judge Julie Muth Goodman, Fayette Circuit Court, Fourth Division, 120 N. Limestone Street, Third Floor, Lexington, KY 40507; and

(ii) Settlement Class Counsel, McBrayer PLLC, 201 E. Main Street, Suite 900, Lexington, KY 40507.

3. Settlement Class Counsel is allowed to update the settlement website to reflect the current status of the settlement and its implementation, and to take down notices, filings, and other information no longer applicable because of the finality of the Court's orders approving the settlement and awarding certain fees and non-taxable costs.

NOTE that the Court announced other rulings and directives regarding implementation of the approved settlement at the 11/12/21 hearing and will issue other written orders thereon.
