ORDER

WHEREAS, on October 11, 2019, this Court heard the Unopposed Motion For Award Of Attorneys' Fees And Costs (the "Motion") brought by Plaintiffs Carmen Andrews, Laurie Munning, Caron Coladonato and Michael Pallagrosi (collectively, the "Plaintiffs");

1 WHEREAS, none of Defendants The Gap, Inc., Gap (Apparel), LLC, Gap International
2 Sales, Inc., Banana Republic, LLC, and Banana Republic (Apparel), Inc. (collectively, the
3 “Defendants”), has filed an Opposition to the Motion;

4 WHEREAS, the Court has independently reviewed the Motion and all of the arguments
5 and evidence upon which the Motion is based, including the Agreement Of Settlement And
6 Release reached between Plaintiffs and Defendants and executed as of January 30, 2019 (the
7 “Settlement Agreement”);

9 NOW, THEREFORE, THIS COURT ORDERS, FINDS AND RULES THAT:

10 1. The Motion is GRANTED.

11 2. The Court FINDS that Plaintiffs’ request that their attorneys in this civil action be
12 awarded a total of Two Million Nine Hundred Seventy Thousand Dollars (USD\$2,970,000.00)
13 in combined attorneys’ fees and costs is reasonable. The Court ORDERS Defendants, jointly and
14 severally, to pay to Plaintiffs’ counsel the sum of Two Million Nine Hundred Seventy Thousand
15 Dollars (USD\$2,970,000.00) in the time and manner specified by Section 2.5(b) of the
16 Settlement Agreement.
