SUPPLEMENTAL DECLARATION OF NAVID ZIVARI REGARDING SETTLEMENT ADMINISTRATION

- I, Navid Zivari, hereby declare under penalty of perjury pursuant to 28 U.S.C. § 1746 that the following is true and correct:
- 1. I am a Project Manager with Angeion Group, LLC ("Angeion"), the Settlement Administrator retained in this matter, located at 1650 Arch Street, Suite 2210, Philadelphia, PA 19103. I am over 21 years of age and am not a party to this action. I have personal knowledge of the facts set forth herein.
- 2. The purpose of this Supplemental Declaration is to provide the Parties and this Court an update to my previous declaration (*see* Dkt. No 60) on the status of settlement administration.

CLAIM FORM SUBMISSIONS

3. The deadline for Class Members to submit a Claim Form was November 25, 2022. As of December 9, 2022, Angeion has received 517 Claim Forms (93 via mail, 424 via the online portal).

4. Claim Forms could be submitted for one or more of the following settlement benefits: credit monitoring services; reimbursement for time spent related to the data breach; and reimbursement for out-of-pocket expenses related to the data breach. Of the 517 Claim Forms received, a total of 351 claims were submitted for credit monitoring services, 230 claims were submitted for lost time reimbursement, and 127 claims were submitted for reimbursement of out-of-pocket expenses. As outlined in the footnote below, claimants submitted claim forms selecting one Settlement Relief benefit only, a combination of Settlement Relief benefits, all Settlement Relief benefits and, in some instances, no Settlement Relief benefits. Claim Forms are currently being reviewed to determine, among other things, whether a claimant is a Class Member.

EXCLUSION REQUESTS AND OBJECTIONS

- 5. The deadline for Class Members to exclude themselves from the Settlement was November 25, 2022. As of December 9, 2022, Angeion has not received any requests for exclusion.
- 6. The deadline for Class Members to object to the Settlement was November 25, 2022. As of December 9, 2022, Angeion has not received any objections to the Settlement.
