**DECLARATION OF WYATT B. DURRETTE, JR. IN SUPPORT OF PLAINTIFFS'
MOTION FOR AN AWARD OF ATTORNEYS' FEES AND EXPENSES FILED ON
BEHALF OF DURRETTE, ARKEMA, GERSON & GILL PC**

I, Wyatt B. Durette, Jr., declare and state as follows:

1. I am a Director, Shareholder and President of the law firm Durette, Arkema, Gerson & Gill PC. I submit this Declaration in support of Plaintiffs' motion for an award of attorneys' fees and reimbursement of costs and expenses in connection with services rendered and costs and expenses incurred by my firm in connection with this litigation.

2. My firm has acted as local counsel to Plaintiffs in this class action. During the period from case inception through May 31, 2021, and at the direction of Plaintiffs' Co-Lead Counsel, my firm has been involved in the following activities on behalf of the Plaintiffs: typical local counsel work of reviewing all pleadings, motions and other documents to be filed in the case and handling the filing thereof; telephone and email correspondence with lead counsel to advise and consult on local customs, rules and practices; deal with issues involving the court and local counsel via telephone and email; assist lead counsel with some matters related to the merits of the case; and attend all hearings in the case and assisting in limited ways with preparation.

3. The schedule attached hereto as Exhibit 1 is a detailed summary indicating the amount of time spent by the partners, attorneys and other professional support staff of my firm who have been involved in this litigation, and the lodestar calculation is based on my firm's historic


hourly billing rates except for work done on document review, which was capped at \$350 per hour for first tier document review, from case inception through May 31, 2021.

4. The total number of hours expended on this litigation by my firm from case inception through May 31, 2021, is 470.50 hours. The total lodestar for my firm is \$185,289.50. My firm's lodestar figures are based on the firm's historic hourly billing rates. The hourly rates for the partners, attorneys and professional support staff in my firm are the same as the usual and customary hourly rates charged for their services in contingent billable matters. The total hours were determined by the examination of contemporaneous, daily time records regularly prepared and maintained by my firm and which have been provided to co-lead counsel for their review.

5. Interim Co-Lead Counsel sent all Class Counsel, including my firm, the Court's approved time and expense reporting protocol. Throughout this litigation, my firm has abided by this protocol as we have performed work, incurred expenses, and submitted monthly reports of our time and expenses. My firm's submission of its compensable time and reimbursable expenses in this declaration and its exhibits comports with these Court-approved time and expense reporting protocol.

I declare under penalty of perjury under the laws of the United States of America that the foregoing is true and correct.
