**ORDER**

1. Promptly after entry of this Order, the Parties will direct the Settlement Administrator to issue Supplemental Notice to the Supplemental Notice Recipients<sup>1</sup> consistent with the terms of the Order Granting Preliminary Approval of Class Action Settlement (Dkt. 61).
2. The date of the Final Approval Hearing is extended until October 27, 2021 at 10:00 A.M. CDT.



Responses to any objections filed with the Court	<b>October 13, 2021</b> (No later than 14 Days prior to the Final Approval Hearing, as set by the Court)

EVENT	CURRENT DATE
Reply, if any, to Class Counsel’s application for Attorneys’ Fees and Service Awards	<b>October 13, 2021</b> (No later than 14 Days prior to the Final Approval Hearing, as set by the Court)
Class Counsel and Defense Counsel submit opt-out list to Court under seal	<b>October 27, 2021</b> (At the Final Approval Hearing, as set by the Court)
Vivid Seats has ability to withdraw from the Settlement if there are more opt-outs than agreed-upon number	Vivid Seats must notify Class Counsel within 10 business days after being served with Opt-Out list. Class counsel then has 30 Days to address the concerns of the Opt-Outs to reduce number of Opt-Outs to acceptable limit.
Entry of Final Order and Judgment	To Be Determined by the Court
Vivid Seats shall make payment to the Cash Fund	Within 30 Days of the Final Order and Judgment
Effective Date	30 Days after the Final Order and Judgment has become final either because appeals have been exhausted or no appeal was taken
Attorneys’ Fees and Costs and Service Awards paid	30 Days after Effective Date
Settlement Website rendered inactive	30 Days after Effective Date
Payment of claims from Cash Fund	As soon as practicable after Effective Date, allowing for notice to Vivid Seats so that Vivid Seats can adjust or update accounts before payment
