### **IN-STORE BENEFIT REGISTRATION INSTRUCTIONS AND FORM**

Settlement Class Members can receive an In-Store Benefit that is a \$3 discount on the first \$10 of any purchase of at least \$10 (pretax), for a maximum discount of \$3 per customer, available for redemption during a consecutive 2-day window (excluding Saturday) at any Dollar General store nationally (the specific dates are to be determined). Limit one In-Store Benefit per person. The In-Store Benefit will only work once, although a customer may redeem the In-Store Benefit on either of the days selected by the Parties. Subject to the terms and conditions applicable to other coupon offers as well as Dollar General's existing Coupon Policy, this In-Store Benefit cannot be combined with any other Dollar General store coupons but can be combined with national manufacturer coupons. The In-Store Benefit excludes: phone, gift and prepaid financial cards, prepaid wireless handsets, Rug Doctor rental, propane, tobacco, alcohol, and milk. Customers can redeem the In-Store Benefit through an existing myDG account or by signing up for a new myDG account using the following link: <https://dollar-web.app.link/e/CRE2025123116>. To redeem the In-Store Benefit using a myDG account, customers must have signed up for a myDG account no later than 7 days before the In-Store Benefit 2-day period begins, and they must enter the phone number that is associated with their myDG account when they complete their eligible purchase transaction. For customers redeeming the In-Store Benefit using a myDG account, the In-Store Benefit will be auto-clipped to their digital wallets, which means that the In-Store Benefit will automatically appear in their myDG Wallet and will automatically be applied to their eligible transaction, provided they enter the phone number associated with their myDG account when completing their purchase transaction. Customers should be aware that the In-Store Benefit may not appear in their myDG Wallet until shortly before the In-Store Benefit 2-day period begins. Customers can cancel their myDG accounts at any time, though customers who cancel their myDG accounts prior to redeeming the In-Store Benefit will be unable to redeem the In-Store Benefit using this redemption method.

Customers who wish to register for the In-Store Benefit without signing up for a myDG account, must complete and return this Registration Form. Completed Registration Forms can either be mailed to the Settlement Administrators at Braun v Dolgencorp LLC d/b/a Dollar General Settlement Administrator Attn: In-Store Benefit 1650 Arch St. Suite 2210 Philadelphia, PA 19103 or submitted on the Settlement Website, [www.DGPriceSettlement.com](http://www.DGPriceSettlement.com). **Registration Forms must be received or electronically submitted by 11:59 pm Eastern Time on April 13, 2026, to be considered timely.** For customers who submit a timely and complete Registration Form, Dollar General will either mail a postcard or send an email with a barcode that will allow the customer to redeem the In-Store Benefit. Those customers then must physically present the barcode at the register of a Dollar General store to redeem during the In-Store Benefit 2-day period. Customers who fail to timely submit this Registration Form may still redeem the In-Store Benefit by signing up for a myDG account by following the instructions above.
