**PLAINTIFF’S UNOPPOSED MOTION FOR PRELIMINARY APPROVAL OF CLASS ACTION  
SETTLEMENT**

Plaintiff Charmayne Bradberry (“Plaintiff”), on behalf of herself and all others similarly situated, respectfully moves this Court for entry of an Order granting preliminary approval of the Parties’ proposed Class Action Settlement Agreement. In support of this Motion, Plaintiff states as follows:

1. After extensive investigation and arm’s-length negotiations between experienced counsel, Plaintiff and Defendant Equifax Information Services, LLC (“Equifax”) have reached a proposed settlement that provides meaningful monetary and injunctive relief to the Settlement Class and resolves all claims at issue in this litigation.
2. The proposed settlement is the product of informed negotiations and falls well within the range of fairness, reasonableness, and adequacy required under Federal Rule of Civil Procedure 23(e).
3. Plaintiff requests that the Court: (a) grant preliminary approval of the Settlement Agreement; (b) certify the Settlement Class for settlement purposes only; (c) appoint Plaintiff as Class Representative and Marcus & Zelman, LLC and Francis, Mailman, Soumilas, P.C. as Class Counsel; (d) approve the form and manner of class notice; and (e) schedule a Final Approval Hearing.
4. Equifax does not oppose the relief sought in this Motion.

WHEREFORE, Plaintiff respectfully requests that the Court grant this Unopposed Motion for Preliminary Approval and enter the accompanying [Proposed] Order submitted herewith.
