**STIPULATED MOTION AND
ORDER TO SET FINAL
APPROVAL HEARING**

Plaintiffs Keefe John and Tori McMillan (collectively, “Plaintiffs”) and Defendant Laboratory Services Cooperative (“LSC”) jointly request the Court set a Final Approval Hearing on January 4, 2027, or any such date thereafter as determined by the Court.

On July 27, 2026, the Court issued an Order Preliminarily Approving Class Action Settlement (“Order”). Dkt. #49. As part of that Order, the Court set a schedule of events for the administration of the proposed settlement and dissemination of classwide notice. *Id.* ¶ 21. In the Order, the Court stated that it would set a Final Approval Hearing “[a]t the Court’s convenience at least 150 days after the entry of this Order.” *Id.* The Parties respectfully request that the Court set a Final Approval Hearing date now so that the Parties can include that hearing information in the notice forms when providing notice to the Settlement Class. Additionally, setting a date for the Final Approval Hearing now will assist the parties in effectuating the deadlines set forth in the Court’s Order, as certain deadlines must be calculated based on the Final Approval Hearing

1 date. *See, e.g., id.* (setting the deadline for the parties to file a Motion for Final Approval as “35
2 days prior to the Final Fairness Hearing”).

3 Accordingly, the Parties respectfully ask that the Court set the Final Approval Hearing
4 for January 4, 2027, which is over 150 days from the date in which the Court entered its Order,
5 or the Court’s next available date thereafter. The Parties further request that the Court permit
6 zoom appearances at the Final Approval Hearing to facilitate attendance by any out of state
7 Parties or Settlement Class Members. A proposed order is included herewith.
