Class Members are eligible to submit a Claim Form

The Class includes all individuals whose personal information was allegedly compromised in the 2020 Data Breach perpetrated against Stockpile, Inc. and Stockpile Investments, Inc. (“Stockpile” or “Defendants”).

The Class specifically **excludes**: (a) Defendants and their employees, principals, officers, directors, agents, affiliated entities, legal representatives, successors and assigns; (b) the judges to whom this lawsuit has been or is assigned and any members of their immediate families; and (c) all persons who have filed a timely Request for Exclusion from the Class.

The Settlement Benefits

Individual Cash Payments

All Class Members who submit a timely and valid Claim Form will be eligible to receive an Individual Class Payment, which is a *pro rata* share not to exceed Ninety Dollars (\$90.00) of the Net Settlement Fund, *i.e.*, the funds remaining from the \$600,000 Gross Settlement Fund, less the following payments in the amounts approved by the Court: Class Counsel Fees Payment, Class Counsel Litigation Expenses Payment, Class Representative Service Payment, and the Administration Expenses Payment.
