**[PROPOSED] ORDER ON PLAINTIFFS’
MOTION FOR APPROVAL OF CLASS NOTICE PLAN**

Upon consideration of Plaintiff’s Motion for Approval of Class Notice Plan (the “Motion”), it is hereby ORDERED that the Motion is GRANTED. The Court further orders:

- (i) The Court finds that the Notice Plan, as defined and described in the Motion and in the Declaration of Steven Weisbrot (the “Weisbrot Declaration”), satisfies the requirements of Fed. R. Civ. P. 23(c) and of Due Process under the United States Constitution.
- (ii) The Court approves the Notice Plan, including both the manner of notice and the proposed content of the notices attached to the Weisbrot Declaration;

- (iii) The Court approves the content of the Email Notice, Mailed Notice, Long-Form Notice, and the Notice Website attached to and described in the Weisbrot Declaration;
- (iv) The Court appoints Angeion Group, LLC (“Angeion”) to implement and administer the Notice Plan as described in the Weisbrot Declaration.
- (v) Consistent with the Notice Plan, the Court sets the following deadlines for particular events and tasks to occur:

Date	Event
_____ (30 days after Order)	Any retailer that has not yet provided full Class Member identifying information to Class Counsel or Angeion shall do so. Angeion shall activate the Notice Website.
_____ (60 days from Order)	Angeion shall compile the Class Member list from the data obtained from retailers and Defendants, including verifying and updating Class Member contact information as described in the Weisbrot Declaration. Angeion and Amazon shall complete the initial mailing of direct notice as described in the Weisbrot Declaration. Angeion shall begin the Media Campaign as described in the Weisbrot Declaration.
_____ (90 days from the Order)	Angeion shall complete any re-mailing of notices, including re-mailing of both the Email and Mailed Notice as described in the Weisbrot Declaration.
_____ (150 days from the Order)	Deadline for Class Members to exclude themselves from the Classes.
_____ (160 days from the Order)	Angeion shall provide a declaration to the parties’ counsel, which shall then be filed with the Court, verifying its implementation of the Notice Plan.
