Instructions: If you purchased VSL#3 between June 1, 2016, and June 19, 2019, you may receive a cash benefit for each unit you purchased, up to forty (40) units. A unit is a bottle or box; each bottle or box in a multipack count as one unit (for example, three bottles packaged together count as three units). You have three options to receive a cash benefit:

- (i) If you received an email or postcard notice with Notice credentials, that means we have obtained records for at least some of your purchases, and you can receive credit for the units for which we have records.
- (ii) If you have retained your own records of your purchase, such as receipts, you can submit such proof of purchase to obtain a cash benefit for the number of units for which you have proof of purchase. If you received a notice **and** have proof of purchase, you can receive credit for the greater number of units between Option 1 and Option 2.
- (iii) If you have no Notice credentials and have no proof of purchase, you may receive a benefit for one (1) unit per household by certifying that you purchased at least one unit of VSL#3 between June 1, 2016, and June 19, 2019.
